BEING A BY-LAW OF THE MUNICIPALITY OF NORMAN WELLS IN THE NORTHWEST TERRITORIES TO REGULATE THE USE AND DEVELOPMENT OF LAND WITHIN THE MUNICIPALITY, PURSUANT TO THE PROVISIONS OF THE PLANNING ACT, R.S.N.W.T., c.P-8, s.14.

WHEREAS it is deemed desirable to regulate certain uses and development of land within the municipality;

AND WHEREAS the Council of the Municipality of Norman Wells has adopted a Community Plan under Section 5 of the Planning Act being By-law XX-XX

NOW, THEREFORE, THE COUNCIL OF THE MUNICIPALITY OF NORMAN WELLS, duly assembled, enacts as follows.

1. This by-law shall be referred to as the "Zoning By-law".
2. This by-law shall come into effect on the date of its third reading.
3. Schedules 1 to 11 are attached and form a part of the by-law.
